Pete Truemper

Truemper is employed at The Timken Company as a principal quality and reliability analyst. After 22 years on the Security & Logistics Committee, he served two years as vice-chair of the Community Parade

BLUES IN SCHOOLS program launches second year



For the second year, the Canton Regional Chamber is bringing the history and culture of the blues genre to our area schools through the "Blues in Schools" initiative. Twenty-five area high school

student musicians (and two adults!) are currently experiencing the program, which offers after-school instruction and mastery class instruction over the course of the 16-week program at Kent State University Stark.

The group of 25 participating students includes nine students returning from the inaugural year.

Participating schools include GlenOak High School, Jackson High School, McKinley Senior High School, Timken Senior High School, Northwest High School, Hoover High School, Central

Catholic High School, Tusky Valley High School, Canton South High School, Louisville High School, Perry High School and Lake Center Christian School.

This year's program instructors include "blues master" Bob Bowers on horns, Erin Vaughn on guitars, Scottie Grewell on drums and Mannie Cahill instructing on bass and keyboard.

The Blues in Schools Program will culminate in a mastery-student performance on-stage in front of thousands at the highly-anticipated Canton Blues Festival in downtown Canton on June 19 and 20.

During his visit, Boehlke will meet with city officials, Chamber groups, community organizations and business leaders. He'll tour Stark County neighborhoods and attend several community events. Boehlke will provide feedback on the current efforts of the Community Building Partnership in Stark County, as well as his perspective of the downtown renewal efforts currently underway in Canton and Massillon. He'll share examples of activities, projects and strategies implemented in other parts of the country that may be beneficial to Stark County.

"Ultimately the goal of David's visit is to understand how we can stimulate hous-

ing development in the Canton central business district and Stark County neighborhoods that will benefit current and future residents," said Joel Owens, director of Community Building Partnership of Stark County. "We believe that David will provide motivation, hope and most importantly, challenges, to our plans and activities." Both the Canton Development Partnership and the Stark Community Foundation have joined Community Building Partnership of Stark County, the community development intermediary, in sponsoring Boehlke's visit.

Boehlke's philosophy on community progress is fairly simple: a community *cannot* thrive unless it is a place where it makes sense to invest *time, effort, and money*; and unless the people are willing and able to manage everyday issues of the community. This balance of people and place dynamics must emphasize the growth of economic and personal equity for residents, especially residents with limited assets.

Boehlke has spent his 30-year career working to renew neighborhoods and downtown city centers by helping local governments and community trustees to understand the "demand side" of the neighborhood equation. His work has spanned more than 100 cities and towns nationwide, with a special emphasis on older neighborhoods in cities with little growth or declining populations. Utilizing his proprietary "Healthy Neighborhoods" concept, an innovative approach that analyzes the stability of a community, he identifies community assets – what's working in a market – as well as what things are undermining community stability. Through this approach, he discovers ways to galvanize neighborhood change.

His technical assessment of Stark County will culminate in formal recommendations and feedback that will guide the Community Building Partnership in future community development plans and projects.

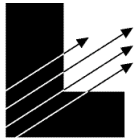

What do you think of the housing choices for YPs in the Canton area?

Kenan Advantage Group is North America's largest bulk transportation and logistics provider to the petroleum and specialty products industries. They operate three unique platforms, including the fuels delivery group, refined petroleum and reusable fuels including gasoline, diesel, aviation and ethanol; specialty products group, food grade products and chemicals; and logistics group, maximizing value for customers through design and delivery of nationwide supply-chain solutions. KAG has sales greater than nearly six times that of their next largest competitor. More than 240 employees work at the corporate office in North Canton, and the company operates 100 terminals, 98 satellite locations and employs over 5,000 people across the country.

KAG recently relocated to the former Seiple Lithograph building on Mount Pleasant Road, growing from 23,000 sq. ft. to 77,000 sq. ft., while remaining in Stark County. These capital improvements required a \$9.1 million investment in the new location, and over \$12 million in proprietary and industry-leading technology. Safety is the number one priority, and they have added anti-rollover devices in 400 of the tractors in their fleet, with plans to extend this to their entire fleet over the next five years.

S&L Harris/Day Architecture is a medium-size architectural firm that provides full service planning, design and construction services for markets throughout Ohio and beyond. They have grown to more than 20 employees since they were founded in 1969. They are the Stark County leader in LEED building sustainable architectural services and six of their staff members are fully accredited LEED professionals. They have sponsored workshops on LEED principles, "green" building practices for energy efficiency and improved building function. The firm is currently planning to expand into a 4,000-4,500 sq. ft. space with sustainable "green" features. The firm invested in Building Information Modeling (BIM), a 3D computer aided drafting software, to improve project management between design and construction. Repeat clients make up 60 percent of the firm's client workload. Recent projects include Aultman Compassionate Care Center, Jackson High School, Tuscarawas and North Canton YMCA, Central Catholic High

School, Stark State College Digital Library and Diebold World Headquarters. In addition to architectural construction, the firm added historic preservation and interior design services to provide their clients with a truly full-service experience.

Family owned and operated since 1912, **Standard Plumbing and Heating Co.** has transformed from a plumbing shop to a full-service mechanical contractor. From permit issues, grossly inadequate building and grounds elements and uninspired food without a food license, Weinfeld had her work cut out for her. She rolled up her sleeves and persevered through these obstacles. As a result, she now runs an award-winning facility with 20 employees, all of whom go the extra mile on unexpected service (whining kids threaten to end a bridesmaid's evening early? Babysitting is no problem!). Weinfeld

prides herself on high-end cuisine at a mid-level budget, and has hired two gourmet chefs, expanded her kitchen and improved her facility to attract customers who want affordable, high-quality experiences.
